SUPPLEMENTARY REGULATIONS

1. Kidderminster Motor Car Club Limited will organise a Taster Permit Car Trial on Saturday 8 June 2024 at Hurtle Hill Farm, Heightington, near Bewdley, Worcestershire, DY12 2YE at Map Ref 138/776703 or what3words <https://w3w/alpha.wink.rots>.
2. The meeting will be governed by the General Regulations of Motorsport UK, (incorporating the provisions of the International Sporting Code of the FIA), these Supplementary Regulations and any written instructions that the organising club may issue for the event.
3. Motorsport UK Permit 136344 has been issued for the event.
4. This taster event is open to the general public and non-members of KMCC who wish to sample car trials. Pre-entry is required.
5. All drivers and passengers (where carried) must produce a valid Competition Licence (minimum, free RS Clubman), Club Membership Card – which is available FOC online at the Motorsport UK website.
6. The programme of the meeting will be as follows:-
Access to the venue will be available from 11:00.
Access to the hills will be from 12:00.
7. Public roads will not be used to link tests.
8. The event will consist of three classes as follows:-
Class 1 Front wheel drive cars
Class 2 Rear wheel drive cars
Class 3 I require use of a loan car from the organisers (limited availability)
9. The entry list opens on publication of these Supplementary Regulations and closes finally on Saturday 1 June. The entry fee for the event is £25.00.
Entries can be made using the online Google form or by completing the event entry form which should be sent either by post to Sheila Roath, Entries Secretary, 72 Willowfield Drive, Kidderminster, Worcs, DY11 5DP or by email to kiddicarclub@blueyonder.co.uk. The entry fee may be paid by cheque, made payable to "Kidderminster Motor Car Club Ltd" or by a BACS payment. Please contact the Entries Secretary for the necessary account details. Entries will not be accepted by telephone.
10. The maximum entry for the meeting, including reserves is 20. Entry fees may be refunded if the event is cancelled.

12. Results will be announced at the end of the day.
13. Any protest must be lodged in accordance with Motorsport UK General Regulation C5.
14. All other General Regulations of the Motorsport UK apply as written except the following which are modified:-
D17.1 - two entries for the same vehicle are permitted.
15. A front seat passenger is not mandatory for this event. If a passenger is carried, then that passenger must be carried for the whole event. Where the driver is under 17 years of age, or over 17 years but does not hold an RTA licence, then a front seat passenger holding an RTA licence and a valid Club Membership Card and experienced in car trials is compulsory (T4.1). No front seat passenger may be under the age of 12 years.
16. All marshals are deemed judges of fact regarding the marks lost on sections (G10.1).
17. Toilet facilities will be available on site.

18. All competitors and their associates commit to positively promote and demonstrate the Motorsport UK's Respect Code. Where any reports of disrespectful conduct are judged to be well founded the organisers may issue warnings or require remedial actions and/or report the matter to Motorsport UK. It is imperative that we promote the safety and wellbeing of young people and adults at risk. In addition to this all participants must be aware of their behaviour and conduct at all times and abusive language and harmful behaviour will not be tolerated. Any such incidents must be reported to the Safeguarding Officer who will also relay the report to Motorsport UK.
